Fence Permit

Building

1. Submittal Requirements
 - a. Building Permit Application
 - b. Blueline Survey/Plot Plan
 - c. PDF plans of building/fence drawings (P.E. engineer seal required if masonry type)
2. Contractor Requirements: Certificate of Insurance – minimum of \$300,000 General Liability Insurance
3. Fees - Plan check fee and permit fee, which are based on the valuation of the project.

Planning

All fence permits must include the following information. Failure to provide all necessary information may result in the denial of the permit.

1. Refer to Chapter 4 of the UDC for requirements.
2. Provide drawing of fence showing dimensions and height.
3. Provide information regarding materials used for fencing.
4. Provide a site plan showing location with respect to property boundaries.
5. Provide the one of the subject property and surrounding properties.

Permits that require plans or attachments need to be submitted on a CD/USB in PDF Format and include the application.
