INTRODUCTION/ INVESTIGATION SUMMARY Introduction

On June 6 through June 7, 2016, Chris Crook and Samuel Cortez of the Texas Commission on Environmental Quality (TCEQ) Houston Region Office conducted a focused odor survey investigation in the Shadow Creek Ranch Subdivision area, in Pearland, in the Harris - Brazoria - Fort Bend County area. The purpose of this investigation (Investigation Typecode FIAIRODOR) was to determine if any odors in the area constituted a nuisance condition. The Houston Region Office Air Section had investigators conducting odor surveys 12 hours a day from 8:00 p.m. on June 6 through 8 a.m. June 10 in conjunction with the Austin Region Mobile Monitoring Unit in the Shadow Creek Ranch Subdivision and surrounding areas. The terrain in the area is flat land and the surrounding land use is residential.

June 6, 2016 Investigation Daily Narrative (8:00 p.m. to 11:59 p.m.)

The investigators surveyed the Shadow Creek Ranch Subdivision and surrounding areas from 8:00 p.m. to 8:00 a.m. (SEE ATTACHMENT 2- Survey Areas). The following is a description of odors detected during this investigation:

The investigators arrived at Survey Area #1 (SEE ATTACHMENT 2- Page 1), Pebble Bay Bridge subsection of the shadow creek neighborhood at 8:00 p.m. No odors were detected at this location. The wind was blowing from the South Southeast at 0-6 mph.

The investigators arrived at Survey Area #2 (SEE ATTACHMENT 2- Page 2), Twilight Bay subsection of the shadow creek neighborhood at 9:00 p.m. No odors were detected at this location. The winds were less than 1 mph and variable.

The investigators arrived at Survey Area #3 (SEE ATTACHMENT 2- Page 3), Fountain Rock subsection of the shadow creek neighborhood at 9:15 p.m. No odors were detected at this location. The winds were less than 1 mph and variable.

The investigators arrived at Survey Area #4 (SEE ATTACHMENT 2- Page 4), Sand Dune subsection of the shadow creek neighborhood at 9:20 p.m. No odors were detected at this location. The winds were less than 1 mph and variable.

The investigators arrived at Survey Area #5 (SEE ATTACHMENT 2- Page 5), Rocky Isles subsection of the shadow creek neighborhood at 9:25 pm. No odors were detected at this location. The winds were less than 1 mph and variable.

The investigators arrived at Sidonie Drive & McHard Road, North of Blue Ridge Landfill at approximately 9:45 p.m. (SEE ATTACHMENT 1.1- Odor Detection Location 1). Strong landfill gas odors accompanied by honeysuckle odors were detected at this location. The investigators documented the odor at this intensity from 9:48 p.m. to 10:35 p.m. The one-minute and 10 minute weighted averages were each very strong intensity. The investigators characterized the odor as highly offensive based on experience, training, and the examples on the TCEQ FIDO chart. The winds were less than 1 mph and variable. (SEE ATTACHMENT 3- Page 1).

The investigators arrived at Triple A Storage located at Hiram Clarke Road & McHard Road at approximately 10:35 p.m. (SEE ATTACHMENT 1.2- Odor Detection Location 2). Very light landfill gas odors accompanied by honeysuckle odors were detected at this location. The investigators documented the odor at this intensity from 10:35 p.m. to 11:35 p.m. The one-minute and 10 minute weighted averages were each very strong intensity, and the one hour weighted average was very light intensity. The investigators characterized the odor as highly offensive based on experience, training, and the examples on the TCEQ FIDO chart. The winds were less than 1 mph and variable. (SEE ATTACHMENT 3- Page 2).

June 7, 2016 Daily Narrative (12:00 a.m. to 8:00 a.m.)

The investigators arrived at FM 2234 & West Drive, North of Blue Ridge Landfill at approximately 12:35 a.m. (SEE ATTACHMENT 1.3- Odor Detection Location 3). Landfill gas odors were detected at this location. The investigators documented the odor at this intensity from 12:35 a.m. to 1:16 a.m. The one-minute and 10 minute weighted averages were each strong intensity. The investigators characterized the odor as highly offensive based on experience, training, and the examples on the TCEQ FIDO chart. The winds were less than 1 mph and variable. (SEE ATTACHMENT 3- Page 4).

The investigators arrived 100 yards south of the intersection of FM521 & McHard Road, North of Blue Ridge Landfill at approximately 2:20 a.m. Very strong landfill gas odors were detected at this location. The investigators documented the odor at this intensity from 2:20 a.m. to 3:20 a.m. During minute 14 of the odor survey the investigators began using a TVA ppm analyzer. At this time the TVA detected readings of Volatile Organic Compounds (VOC's) ranging from 98 parts per million (ppm) to 210 ppm. The one-minute, 10 minute, and one hour-weighted averages were each very strong intensity. The winds were less than 1 mph and variable. (SEE ATTACHMENT 3-Page 5).

The investigators conducted additional surveys for the remainder of the morning and did not note additional odors. The investigators departed from the area at 8:00 a.m.

#### GENERAL FACILITY AND PROCESS INFORMATION

Blue Ridge Landfill is a municipal solid waste (MSW) landfill located at 2200 Farm to Market (FM) 521, in Fresno (Fort Bend County), Texas and is authorized to operate by TCEQ General Operating Permit No. O-01472. The landfill was re-issued this permit on August 23, 2003. The surrounding land use includes light industry, agricultural production and several residential subdivisions.

Agreed Orders, Court Orders, and Other Compliance Agreements

Based on review of CCEDS, regional office files, and enforcement database, there were no agreed orders, court orders and other compliance agreements for the site.

#### Complaints

Based on review of CCEDS, there were approximately one thousand two hundred and seventy six (1,276) complaints filed against the regulated entity for the past year (August 1, 2016 through June 30, 2016).

Based on review of CCEDS and enforcement database, there were no prior enforcement issues in the last five years.

#### ADDITIONAL INFORMATION

Conclusions, Recommendations, and Current Enforcement Actions

Landfill gas/honeysuckle odors were detected at four locations during the investigation. Investigators characterized the landfill gas odors as highly offensive based on experience, training, and the examples on the TCEQ Frequency, Intensity, Duration and Offensiveness (FIDO) chart. The landfill gas odor and honeysuckle odor were the same as experienced by the investigators on May 25, 2016 (investigation #1349609) and May 26, 2016 (investigation #1337795). In order to confirm a nuisance as a single occurrence, a highly offensive odor has to last one hour with a very strong intensity. During this investigation, the investigators experienced a landfill gas/honeysuckle odor which was highly offensive and very strong for one hour. This odor constitutes a nuisance condition. During this investigation and in investigation #1331231, Blue Ridge Landfill was determined to be the source of the odors detected at offsite locations. The findings from this investigation will be addressed in investigation #1331231.




