Blue Ridge Landfill Settlement Agreement- Prohibited Route Violation

Dear Mr. Rogers:

As you are aware, the City and Republic Services ("Republic") are parties to the Blue Ridge Landfill Settlement Agreement. Pursuant to Section II (K) of the Agreement, Republic shall prohibit its waste trucks and any waste truck it or any parent entity exercises control over, except for local service, from using either Broadway of Shadow Creek Parkway, east of FM 521. It was brought to your attention on March 13, 2017 that Republic hauled a roll off dumpster along Shadow Creek Parkway in violation of the Agreement. In an email exchange (see attachment) regarding the violation you conceded that the truck in question was not servicing a customer along Shadow Creek Parkway as authorized by the Agreement. Pursuant to Section IV (F) of the Agreement, if Blue Ridge, or waste trucks under Blue Ridge's control are found by the Pearland Municipal Court, or by admission of Blue Ridge to have used Prohibited Routes under the Agreement, Pearland can seek, and Blue Ridge will not oppose, damages in the amount of \$1,000.00 for each breach.

The City believes Republic's compliance with the terms of the Agreement is of paramount importance, therefore the City demands that Blue Ridge submit payment of \$1,000.00 to the City, as damages for the above referenced violation, within ten (10) business days of receipt of this notice.
