

- NARROW LANES DO NOT PROVIDE ADEQUATE SAFETY




PROPOSED PROJECT DESCRIPTION

- WIDEN TO A 4-LANE, DIVIDED, CONCRETE CURB-AND-GUTTER ROADWAY
 WITH UNDERGROUND STORM SEWER SYSTEM
- ADD A CONTINUOUS SHARED USE PATH ON WEST SIDE
- ADD PEDESTRIAN RAMPS
- ADD LANDSCAPING AND IRRIGATION

IMPLEMENTATION TIMELINE

- CONSTRUCTION TO BEGIN: 1ST QUARTER OF 2019
