Investigation Comments:

Introduction

The Houston Regional Office received forty complaints as part of the ongoing complaint investigation of various odors near the Shadow Creek neighborhood located in the City of Pearland, between Brazoria and Fort Bend counties, Texas. Of the forty complaints received between September 8 and September 12, 2016, 34 were received via email and six were received by phone. The odors were particularly strong on the morning of September 9, 2016, when the majority of the complaints were received. Meteorological conditions for the morning of September

9, 2016 were as follows: an average temperature of approximately 81 degrees Fahrenheit and an average wind speed of 1.1 miles per hour in a predominantly south-northeast direction. This information was retrieved using Weather Underground website (Station ID: KTXPEARL23). The TCEQ Incident number associated with this complaint investigation is 243562.

The complainants stated that the odors in the area were prevalent late at night and into the early morning and have been occurring intermittently for months. Most of the complainants alleged that the odors were associated with Blue Ridge Landfill. Descriptions of the odor included rotten eggs, sour, and garbage. The complainants also characterized the odors as strong and putrid. A few complainants also described the odor as being petrochemical, methane and sulfur, or sweet, and one complainant stated that the smell was like a dead animal or fish. Two complainants alleged health effects. One complainant stated that the odor was affecting the ability to breathe. Another complainant alleged that they had a pounding headache and were feeling sick to the stomach.

The complaint was assigned to TCEQ investigator, Ms. Eresha DeSilva, on September 12, 2016.

Investigation Narrative

On September 14, 2016, TCEQ investigators Eresha DeSilva and Jessica Fox arrived in the Shadow Creek Ranch area at 7:45 AM. Meteorological conditions were as follows: partly cloudy sky with a temperature of approximately 78.4 degrees Fahrenheit and a wind speed of 2.7 miles per hour in a west-northwest direction. This information was retrieved using Weather Underground website (Station ID: KTXPEARL23). The investigators drove along Shadow Creek Ranch Parkway towards Akzo Nobel then went south on Farm-to-Market (FM) 521. The investigators stopped at an unpaved driveway to an access gate onto Blue Ridge Landfill, sitting on top of a pipeline corridor, located off of FM 521 and close to Ginger Cove Court at 7:50 AM. No odors were observed at this location between 7:50 AM and 7:53 AM.

Next, the investigators proceeded to drive through the Shadow Creek Ranch community to perform odor observations. The investigators drove east on Broadway from FM 521, then turned north into the community on Kingsley Road. From Kingsley Road, the investigators turned west onto Trinity Bay Drive towards Shadow Creek Ranch Parkway. No odors were observed. The investigators then went east on Shadow Creek Ranch Parkway, turned south onto Reflection Bay, and proceeded around the Clear Lake Loop within the Shadow Creek Ranch community. There were light smells of freshly cut grass throughout the community, as many of the main roadsides were being manicured by workers. After making the loop, the investigators drove east on Emerald Bay and followed Kirby Drive south into a newer community south of Broadway Street. The investigators then turned west onto Magnolia Cross, north onto Southern Trails Drive, and west onto Broadway Street. Finally, the investigators retraced the route from Kingsley Drive to Trinity Bay Drive towards Shadow Creek Ranch Parkway before leaving the area. An area/survey route map is provided in Attachment 1. No odors were detected. The investigators departed the area at 9:15 AM.

Facility Authorization Narrative

The investigators conducted a general area survey for odor. The investigators did not enter any facilities, because no odors were detected.

An exit interview was not conducted since there were no alleged violations, additional issues, or records requested.


