License renewals are due no later than January 15<sup>th</sup> with the appropriate application fee. Failure to obtain license will result in immediate cessation of all food services. **License is valid for the calendar year issued and expires on Dec.31<sup>st</sup> of the year issued.** Establishments beginning operation after Jan 15<sup>th</sup>, will be charged a prorated fee. **Renewal applications and fees received after Jan 15<sup>th</sup>, will be charged one and one half times the original license fee.**
