Pursuit Report 2022



Pursuit policy 504.3.12 Annual Report requires a summary of all vehicle pursuits for the prior year. Vehicle pursuits are inherently dangerous to both the officers involved and the public. The Pearland Police Department takes its obligations seriously to provide the most effective and efficient police service possible with the least adverse impact on our citizens. We are committed to protecting our citizens while ensuring the manner in which we do so does not place the public at risk of greater harm. This process requires continuous evaluation of the risks and benefits of each action.

Officers are trained by the department in pursuit tactics and emergency driving. However, as skilled as an officer might be in these situations, the vehicle being pursued may not have a competent driver and at times, the driver may be under the influence of alcohol or drugs. Both the involved officer(s) and the supervisor are charged with continuous evaluation of the pursuit as it occurs and are required to call off the pursuit when either believe the risks to the officer or the public outweigh the need for immediate capture of the suspect.

Texas Law Enforcement Best Practice 7.13 and Pearland Police Department Policy 504 require a written report be completed when an officer pursues a vehicle. Each individual report is immediately reviewed through the chain of command to ensure the action is within department policy. If the officer initiated or participated in a pursuit inappropriately, a departmental investigation is required and the officer may receive additional training or, in some case cases, discipline up to and including termination from employment.

- 12/12 Unknown driver initiated on traffic. Supervisor terminated. Reviewed within policy.
- 12/21 A/M driver initiated as wanted person/vehicle. Officer terminated as driver ID known. Warrant for evading. Reviewed within policy,
- 12/30 W/M driver initiated for traffic. Driver stopped and fled on foot. Charged with evading. Reviewed within policy.

Of the three pursuits that included policy violations there were no injuries or property damage. Each was resolved through counseling or additional training for the officers involved.

28 pursuits originated as simple traffic violations. 19 began as criminal investigations such as when a citizen calls in a theft (as an example). 7 began as a known wanted person or vehicle. 1 began as a DWI. A new category LPR FLOCK hit resulted in 3 pursuits.

22 of the listed pursuits were terminated by either the officer or the supervisor. Pursuit termination is most often for safety reasons such as traffic conditions, weather, etc. 3 of the terminated pursuits were due to the identity of the fleeing driver being known.

15 pursuits ended by the fleeing driver ultimately stopping voluntarily. 13 ended by the suspect vehicle crashing. Of those that crashed two collided with other, uninvolved vehicles. 1 pursuit ended by use of a spike strip.
