The City of Pearland hereby notifies to the above-named Public Entity that the City intends to annex approximately 287 acres of land within the City of Pearland Extraterritorial Jurisdiction (ETJ), located north of FM518/Broadway, east of Stone Road, west of Max Road, and approximately 1,900 feet south of McHard Road, which is territorially identified as Brazoria County Municipal Utility District No. 16.

In addition to the description of the area to be annexed, the City must provide your entity with the following information:

- 1. The financial impact on Brazoria MUD No. 16 will include the elimination of property tax revenue previously collected by the MUD prior to annexation, commensurate with the dissolving of the District. The financial impact will also include the elimination of the MUD's debt service and operating cost obligations, and other encumbrances associated with the operation of the MUD prior to annexation. The estimated amounts of these impacts at the time of the intended annexation include, but are not limited to:
 - a. Revenues \$1,360,706 reduction in Property Tax Revenue;
 - b. Obligations elimination of \$428,500 in Operating Costs;
 - c. Debt Service elimination of approximately \$14,621,638 or more in debt; and
 - d. Transfers transfer of approximately \$2,800,000 in cash and investments to the City.
- 2. With the exception of the above-described limitations the annexation will have where Municipal Utility District No. 16 is concerned, as the MUD will dissolve, City of Pearland has no proposal to abate, reduce, or limit any financial impact on the public entity or political subdivision.
